Description Epidemiological population dynamics models traditionally define a pathogen's virulence as the increase in the per capita rate of mortality of infected hosts due to infection. This package provides functions allowing virulence to be estimated by maximum likelihood techniques. The approach is based on the analysis of relative survival comparing survival in matching cohorts of infected vs. uninfected hosts (Agnew 2019) <doi:10.1101/530709>.

anovir: Analysis of Virulence

Description

Epidemiological population dynamics models traditionally define a pathogen's virulence as the increase in the per capita rate of mortality of infected hosts due to infection. The ANOVIR package provides functions allowing virulence to be estimated by maximum likelihood techniques. The approach is based on the analysis of relative survival applied to the comparison of survival in matching cohorts of experimentally-infected vs. uninfected hosts (Agnew 2019).

Details

The analysis of relative survival is a statistical method for estimating excess mortality. Excess mortality occurs when a target population experiences greater mortality than would be expected for a given period of time. Here excess mortality is estimated in the context of empirical studies where survival in populations of experimentally infected hosts is compared to that in matching populations of uninfected, or control, hosts. In this context the relative survival approach assumes the rate of mortality observed in the infected treatment arises as the sum of two independent and mutually exclusive sources of mortality, (i) the 'natural' or background rate of mortality, and (ii) an addition rate of mortality due to infection.

The background rate of mortality is the expected rate of mortality hosts in the infected treatment would have experienced had they not been exposed to infection; it is estimated from mortality observed in the matching uninfected control treatment. When there is background mortality, the rate of mortality of infected hosts due to infection is not directly observed; however it can be estimated from the difference in mortality observed for an infected treatment and that observed in a matching control treatment.

The two sources of mortality assumed in the relative survival approach, and the additive effect of their rates for infected hosts, is also found in the population dynamics models on which most epidemiological theory is based. The additional rate of mortality of infected hosts due to infection is generally how these models define pathogen virulence.

Consequently a single hazard function, with a single pair of values for its location and scale parameters, can be used to describe the pattern of mortality due to infection for the infected population as a whole.

Details

The proportional hazards assumption requires, $h_1(t) / h_2(t) = c$, where $h_1(t)$ and $h_2(t)$ are two hazard functions at time t , and c is a constant. Details

p1 is the estimated proportion of hosts associated with the location and scale parameters a2, b2; $0 \leq p1 \leq 1$.

Details

To generate data, the function collects the input variables for the probability distributions chosen to describe the background mortality and mortality due to infection, along with values for their location and scale parameters, respectively. These are used to parameterise cumulative survival functions for the two sources of mortality. These functions are solved for time t , where the value of $S(t)$ is drawn from a random uniform distribution between 0 and 1; this yields values of t corresponding with values of survival drawn at random from the cumulative survival curve.

Values of t are rounded up to the nearest integer. This introduces a bias as recorded times of death are later than actual times of death; this bias occurs in real datasets when sampling occurs at discrete intervals. This bias can be partially offset by taking the mid-point of sampling intervals as the time

of death. Mid-point times of death are also provided, assuming sampling occurs at each integer interval.

In the case of hosts from infected treatments, two potential times of death are calculated; that due to background mortality and that due to infection. The earlier of the two defines the time of death, providing it is not later than the value of `t_censor`.

The value of `t_censor` defines the time when any individuals remaining alive are right-censored. The act of censoring is assumed to occur after populations have been sampled for mortality, i.e., if mortality is recorded daily and the last day of an experiment is day 14, the populations are checked for mortality at the beginning of day 14 and any individuals alive after this are classed as censored on day 14. The timing of censoring is 'true' as individuals were known to be alive at the time they were censored. Hence times of censoring do not vary for 'time' or 'mid-time', whereas they do for individuals dying at an unknown time between two consecutive sampling times.

Warning

The lower tail of Gumbel distribution can yield negative estimates for times of death as the random variable replacing cumulative survival approaches one; $S(t) \rightarrow 1$.
